From Company:

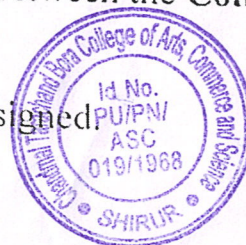
1. To contribute in designing the academic courses and support for visiting faculty.

In this regard we are pleased to sign the MOU between the **College** and **Enterprise** to meet the outcome of this MOU.

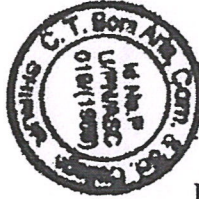




